Goal #1

State Goal

Centennial middle school will improve proficiency on end-of-level testing by at least 5% in English Language Arts, math, and science. We will measure this by comparing RISE test scores from 2023-2024 to 2022-2023.

Our ELA and science goals were not met last year, and we are still behind the state and national averages. Math did reach their goal, but they are still only 38% proficient. We feel there is still room for growth in all three core areas.

The first way we will address math and ELA is to increase the number of teachers in each department in order to provide "double blocks" to our general education students. This means those students will have math and ELA every day instead of every other day. We will use our budget to pay for one teacher over the school's allotted FTE to help make this possible.

Second, we will increase teacher capacity to give common formative assessments, gather data by student by standard, and to implement effective interventions and extensions accordingly. To do so, we will send at least one teacher from each PLC team to professional development, then have them present to/teach the rest of their team.

We are currently in turnaround status for EL students and are in our third year identified as such. We will continue our current practice of monitoring WIDA ACCESS scores, placing students in ELD classes, and sharing data with teachers through the program Ellevation. Data for our goal specifically will come from RISE test scores and school report cards. Formative assessment data in PLC teams will also be monitored for more immediate feedback and interventions.			
Action Plan Steps and Expenditures		close	
First, we will continue monitoring WIDA proficiency levels. All EL students will have access to an ELD class. Their data will be shared with all of their teaches. PLC teams will monitor formative assessment data and implement interventions accordingly. We will hire and train at least 3 ESOL aides who speak the same language as the EL students will go into core classes with those students.
